### **Program Highlights**

- California, Texas, Florida, Ohio, Utah, Alaska, and Arizona have been assigned NEPA responsibilities under the 327 MOU with FHWA.
- California, Arizona, Nebraska, and Utah have been assigned NEPA responsibilities under the 326 MOU with FHWA.
- Combined MOUs are being used by Texas, Alaska, Ohio and Florida
- Caltrans has saved significant time in reviewing and approving its NEPA documents since
  undertaking NEPA Assignment. A median time savings of 11.8 months has been achieved in
  approving draft EAs; 15.2 months for final EAs (FONSIs); 28 months for DEISs; and 124.0
  months for FEISs.
- Caltrans works closely with its partners local agencies, consultants, and FHWA in delivering on the Congressional mandate to accelerate project delivery of its projects.
