# **Exhibit 6.7: Minimal Recordation for Certain Exempted State-owned Resources**

### **Background**

Under PRC 5024(b), Caltrans is required to inventory all state-owned structures over 50 years old under its jurisdiction that are listed in or eligible for the National Register of Historic Places (NRHP) or that are registered for or eligible for registration as California Historical Landmarks (CHLs), and inventory Caltrans-owned structures in our right-of-way before approval of any project that may alter their original or significant features or fabric or that involve transferring. relocating or demolishing the structures. In addition, under PRC 5024(e), Caltrans is required to submit annual inventory updates to the State Historic Preservation Officer (SHPO).

Under Stipulation VIII.B of the PRC 5024 MOU (5024 MOU)<sup>1</sup>, Caltrans makes a good faith effort to identify Caltrans-owned resources that may be affected by a project and evaluates them when warranted to determine NRHP/CHL eligibility. In accordance with 5024 MOU and the Section 106 PA (106 PA)<sup>2</sup> Stipulation VIII.C.1 and Appendix 4, certain categories of resources with minimal potential to meet the NRHP/CHL eligibility criteria may be exempted from evaluation by Caltrans Professionally Qualified Staff (PQS) pursuant to Appendix 1 of the 5024 MOU and 106 PA or consultants who meet the Caltrans Professional Qualifications Standards described in Appendix 1.

In order to comply with Caltrans' PRC 5024(b) responsibilities, some exempted resource types require minimal recordation, as described below.

### **Exempted Resource Types Requiring Recordation**

Minimal recordation is required for Caltrans-owned built-environment resource types 3 through 7 exempted in accordance with Appendix 4 of the 5024 MOU/106 PA:

- Resource Type 3: Caltrans-owned buildings, structures, objects, districts, and sites so altered as to appear less than 30 years old
- Resource Type 4: Caltrans-owned buildings, structures, objects, districts, and sites 30 to 50 years old
- Resource Type 5: Caltrans-owned buildings, structures, and objects moved within the past 50 years
- Resource Type 6: altered Caltrans-owned buildings, structures, objects, districts, and sites whose alterations appear to be more than 30 years old
- Resource Type 7: Caltrans-owned Post-World War II builders' houses and housing tracts

#### Recordation

Record exempted Caltrans-owned resource types 3 through 7 on a DPR 523 Primary Record form that is scanned into the Caltrans Cultural Resources Database (CCRD)<sup>3</sup>. Alternately, the form can be electronically created by using data in the CCRD. Enter the following information into the CCRD, which results in a DPR 523 Primary Record when printed:

- Resource name
- County
- Caltrans' County/Route/Postmile or address and city
- Description:

- Construction date(s) age (actual or estimated)
- Owner
   State "Caltrans" and the district where resource is located. No other information needed in this field.

#### Date resource was recorded

Consultants without access to CCRD must complete a DPR 523 Primary Record and provide an electronic copy to the Caltrans District cultural resources staff to input into CCRD in addition to any other required copies and documents that may be required.

The Primary Record is the only DPR 523 form needed. When the project or activity is the transfer of a resource out of Caltrans ownership, recordation on a DPR 523 form is not required.

Once the record is included in the CCRD, that resource is considered to have been inventoried. New or additional DPR 523 forms do not need to be completed for later project/activities involving this resource unless PQS or a qualified consultant determines that it warrants updating or evaluation.

The addresses or locations of Caltrnas-owned exempted resource types 3 through 7 should be noted in the Historic Resouces Evaluation Report (HRCR) or Historic Property Survey Report (HPSR). Exempted resources of any type that are not owned by Caltrans do not need to be listed in the HRCR or HPSR.
