## FACT SHEET: CALIFORNIA 2025 FSTIP FEDERAL PLANNING FINDINGS

#### **OVERVIEW**

On December 16, 2024, the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) sent Caltrans' Director the approval letter and the Federal Planning Finding (FPF) for the 2025 Federal Statewide Transportation Improvement Program (FSTIP). The Planning Finding included 8 federal recommendations for 2025, 2 carried over from the 2023 FSTIP and 3 commendations recognizing Caltrans' efforts.

### **KEY TAKEAWAYS**

Caltrans is developing a strategic framework to fulfill the intent of the FPFs by September 2026, ahead of the 2027 FSTIP submission. Failure to implement and communicate necessary actions to federal partners may pose a risk to losing federal highway and transit funding, project delays or cancellations and increased project oversight. To meet federal expectations, Caltrans seeks support and collaboration both from internal and external partners to address the FPFs in the federal planning and programming process. This partnership will help manage expectations, foster transparent discussions, and enhance awareness of state and federal requirements to ensure California conforms with federal regulations.
