

# **REDWOOD MOBILITY EDUCATION PROGRAM**

#### PROJECT SUMMARY

#### ATP PROJECT COST: \$600,000

The Redwood Mobility Education Program (RMEP) was sponsored by the Humboldt County Department of Health and Human Services – Public Health, Redwood Community Action Agency, and BikesThere, a local pedestrian and bicycle advocate group. The program aimed to increase walking and cycling in Eureka City Schools by incorporating middle school student mobility, community, and leadership education into the school day and afterschool programs. RMEP developed an afterschool elementary through middle-school walking and bicycling curriculum and toolkit. Policy change was catalyzed by a middle school students' Photo Voice project presentation, which included the story of a student fatality, to the Eureka City Council who then implemented the Safer School Zone Act to extend school zones and reduce speed limits around seven schools in the city: 6 schools had speed limits reduced to 15 mph, 1 school had the speed limit reduced to 20 mph.

#### Activities

RMEP provided training on civic engagement and opportunities for middle school students to make presentations to the community and elected officials on unsafe walking and bicycling issues they identified near Eureka City Schools.

Middle school youth led a walkability assessment, followed by a Photo Voice project, which concluded with a safety campaign called, the "Falcon Flyway," aimed at bringing awareness to students and parents about safe walking and bicycling routes to get to school.

A model roadway and intersection (20' x 20') as well as flashlights, reflective materials, and bike lights were available along with the curriculum to check out from the Humboldt County Office of Education.

Physical activity pledges, pedestrian and bicycle safety lessons, and support for regular Walk to School Day events were led at four elementary and one middle school.
