Guidelines:

Final ATP guidelines are posted on the web...are these the same as Chapter 22 of the LAPG? (Michael Karoly)

There are 2 guidelines: the CTC ATP Guidelines and the Caltrans Chapter 22 ATP Guidelines.

You will have final version completed of guidelines but the application is due in 1 month following? Is this right? (Lupe Camacho)

The CTC ATP Guidelines are complete. The Caltrans Chapter 22 ATP Guidelines are Draft (pending Caltrans district comments). The Caltrans Chapter 22 ATP Guidelines mostly cover processes that occur after an application has been selected. The applications are due July 31, 2018.

The website states that the final guidelines will be available in June 2018. Will this be June 1st or June 30th? (Lupe Camacho)

Project Types:

What exactly is the definition of Infrastructure project? (Mahendra Patel)

Infrastructure projects are capital improvements (i.e. building something). Non-Infrastructure projects entail education, encouragement, and/or enforcement. A plan project is the development of a community wide plan.

What makes a project eligible? If the project is in an ATP adopted by the County, is it eligible? (Siri Champion)

Eligibility must be considered on each element of a project's scope (eligibility is not established based on the entire project). The CTC ATP guidelines language states: *"In order for an item to be eligible for ATP reimbursement, that item's **primary use or function** must meet the ATP purpose". Per ATP legislation, **the purpose of ATP is to encourage increased use of active modes of transportation.***

In determination of application type, "Total Cost" includes all phases, correct? (David Kinzle)

Correct. All phases and funding types (not just the ATP funded work).

If an applicant submits a Plan application, can they also submit other applications (Large/Medium/NI)? (Ilya Malinsky)

Yes, an applicant can submit multiple applications.

Are there set aside funds for each application category? such as large, medium and small projects.

Application- Part A:

When listing past projects, do applicants only include projects for which their agency was funded? Or, should we include projects in which we are or will be a subcontractor? (Lynn Lauridsen)

[This may be a gray area depending on the scope/scale of the "subcontractor" work, but in general, the expectation is for past projects the 'applicant' has received funding for.](#)

What if the project is a global SRTS plan that will impact over 50 schools? Do you need school information for every single school? (Catherine Thibault)

[In general, the expectation is for the applicant to provide school information for every school impacted. If this does not seem reasonable to an applicant, they can ask Caltrans for clarification based on the specific details of the project.](#)

In an NI project app type, why are questions being asked related to capital projects, construction and right of way? (Rochelle Wheeler)

Funding/Project Scheduling:

What constitutes committed local funds? (Ron Chan)

[This usually means funds that the agency has formally committed to a project through a council/board resolution \(or equivalent\). For funding that does not meet this criteria, the applicant could seek clarification from CTC staff.](#)

What is the minimum match required? (Shahid Abbas)

[No minimum match is required. If your project is a Medium or Large Infrastructure, you can get points with as little as 1% of your total project cost.](#)

If using local funds for pre-con, may funds be used prior to July, 2019 and still apply as leverage/match? (Adam Parania)

Yes for “leveraging” - for Medium and Large Infrastructure projects.

For projects within Caltrans/State right-of-way there was some verbal advice to include approximately two weeks to establish an agreement with Caltrans for R/W encroachment. Can you confirm that we should allow for two weeks within the application schedule so that the application should acquire and attached an agreement with Caltrans as part of the application packet? (Robert Gonzales)

It is recommended to provide more than two weeks. More information on this process is available in the Application Instructions posted on the Caltrans Cycle 4 website.

Would it be more prudent to request only pre-con in cycle 4 and con in cycle 5 or all phases in cycle 4? (Adam Parania)

You can only split cycle funding on Large Infrastructure projects. If your project is very complex, and you are concerned that you might not be able to get your NEPA and ROW cert in time for a Construction allocation deadline of June 30, 2023 (Plus a non-guaranteed time extension of 20 months), then you should plan to split your project. Keep in mind that you will have to reapply for the next cycle, and you are not guaranteed to get selected.

Will there be additional guidance for requesting pre-con funding for large infrastructure projects? Such as the level of detail needed for the planned construction funding. (Adam Parania)

If additional guidance is needed (over the CTC guidelines and other guidance documents posted on the Caltrans website), the applicant is encouraged to contact their Caltrans ‘District’ ATP coordinator.

Do you need to identify construction costs if you are only requesting funding for PA/ED? (Kevin Tucker)

Yes. It would be part of the future funding for the project.

What is the FY 23/24+ in the PPR for? (Nicole Cichy)

It is for or Large Infrastructure projects that aren’t requesting all of their funds in Cycle 4.

If you received prior ATP funding for Design, would that be addressed in the Project Funding table? (Paul Keener)

[Each application can only have 1 DAC definition. You may have to enter different data to see which type gives your project the best score. Your Plan can have some non-DAC tracts in it. Per the CTC ATP guidelines the Plan must encompass DAC.](#)

[Yes, count data is required for all application types, except Plans. It is up to the applicant to determine a replicable methodology that represents the entire project/program limits. See the application instructions for more information.](#)

Technical Questions:

How is 'stress level' determined? (Jenny Weiss)

Level of Traffic Stress (LTS) is a rating given to a road segment or crossing indicating the traffic stress it imposes on bicyclists. Levels of traffic stress range from 1 to 4.

- LTS 1: Strong separation from all except low speed, low volume traffic. Simple crossings. Suitable for children.
- LTS 2: Except in low speed / low volume traffic situations, cyclists have their own place to ride that keeps them from having to interact with traffic except at formal crossings. Physical separation from higher speed and multilane traffic. Most adults can tolerate.
- LTS 3: Involves interaction with moderate speed or multilane traffic, or close proximity to higher speed traffic.
- LTS 4: Involves interaction with higher speed traffic or close proximity to high speed traffic.
