## *Laurie provided a detailed report and discussion with the TAC. The summary of report below for this cycle:*

- Engagement this cycle;115% in site visits this cycle. Augmentation helped to fund more projects.
  - 96 visits
  - 129 projects discussed
  - 6 branch workshops
  - 15 total workshops
  - 9 central workshops
  - Lessons Learned:
    - Successful site visits: application prepared.
    - o Virtual site visit worked and will continue. It does take a lot of planning.
    - Central Workshops: plan how to get more participation for virtual workshops.
    - Branch Workshops; not successful. Will need to rethink and consider in person as next steps.

#### ATP Feedback/Discussion:

• Staff shared feedback in person; added value and was more personal.

- More online /hybrid moving forward. Great site visits.
- Consider smaller groups.
- Engagement issues; continue discussion on strategies
- Toolkit; better preparation for site visits.
- Technical assistance to prepare application for Cycle 6-7 cohort.
- Insights gained to information for more engagement and site visits.
- Resource issue/homework to prepare.
- Regional project success at workshop.
- Noninfrastructure; need more help
- Project costs rising each cycle.
- Projects; increase costs in larger projects
- Project funding based on priority of combination of small/medium/large projects.
- Santa Cruz has the largest project.
- Cycle 6; IIJA funding at \$650M. Augmentation funding may increase funding.
- Resource issues; grant writing vs implementation.
- Sponsors are more confident to submit ATP applications after seeing other project get awards.
- Application is setup for small and large projects.
- Simplify application, change rubrics, or modify to accommodate small and large projects.
- Grant writing; challenge for resource constrained agencies.
- Two step process to submit application; small application review and invitation to complete larger applications with help from outside team.
- Resource impact to participate; resources may be pulled away from participating on other projects.
- Application is complex.
- Agencies that make ATP a priority is important.
- Assistance can be requested to help with grant writing.
- Application is not user friendly.
- Evaluator selection.
- Challenge is reviews of DAC application submissions.
- Funding Class 3 bikeways; Bay area.
