1. Workshop and Guideline Updates – CTC Staff

Beverly Newman-Burckhard

- CTC is doing center, branch, and site updates.
- Formalized guidelines work with small workgroup
- Holding 2/23 workshop to present guidelines
- Making limited changes.
 - Electronic applications, project thresholds/sizing, small 3.5 million, med over 3.5--10 mil, and large over ten million working with Department of Housing and development.
 - Minor changes Department of Aging to integrate language, med/large – low stress networks
 - Non infrastructure projects will have a funding model and equal scoring
 - Public engagement due to covid. Challenges and strategies. Add a non-scored section

2. Site Visit Updates

Laurie Waters

- This cycle virtual site visits were conducted. Trying to continue a way; site visits are popular and are all booked up.
- We have ninety-four site visits scheduled ranging from 1 3 hours, 132 projects that we are viewing and conducted forty-nine site visits to date. Started Nov 5 and expect to complete in a 5-month period by March 11.
- Increase in projects from last cycle and new ones too.
- Giving an early glimpse of submissions and amazing to see new projects (networks, vision, active transportation) New projects are in the large category; getting anxious for this next cycle and may have limited funding for these projects in the future. May need to start thinking about funding for size of projects. Draft guidelines and fund estimates for each program cycle. Jan '22 got a bump in funding from of draft fund estimates of approximately six hundred million. This may allow funding for a few more projects.
