PROCLAMATION OF A STATE OF EMERGENCY

WHEREAS in February 2024, severe winter storms ("February 2024 Storms"), including a series of atmospheric river events, struck California between February 9, 2024, and February 29, 2024, significantly impacting Glenn, Humboldt, Marin, Napa, Santa Clara, Solano, and Trinity Counties; and

WHEREAS the February 2024 Storms brought heavy rain, flooding, and high winds across the State which caused landslides, slipouts, potholes, various road closures, debris flows, and widespread power outages; and

WHEREAS under the provisions of Government Code section 8558(b), I find that conditions of extreme peril to the safety of persons and property exist due to February 2024 Storms in Glenn, Humboldt, Marin, Napa, Santa Clara, Solano, and Trinity Counties; and

WHEREAS under the provisions of Government Code section 8558(b), I find that the conditions caused by the February 2024 Storms, by reason of their magnitude, are or are likely to be beyond the control of the services, personnel, equipment, and facilities of any single local government and require the combined forces of a mutual aid region or regions to appropriately respond; and

WHEREAS under the provisions of Government Code section 8625(c), I find that local authority is inadequate to cope with the magnitude of the damage caused by the February 2024 Storms; and

WHEREAS under the provisions of Government Code section 8571, I find that strict compliance with various statutes and regulations specified in this Proclamation would prevent, hinder, or delay the mitigation of the effects of February 2024 Storms.

NOW, THEREFORE, I, GAVIN NEWSOM, Governor of the State of California, in accordance with the authority vested in me by the State Constitution and statutes, including the California Emergency Services Act, and in particular, Government Code section 8625, **HEREBY PROCLAIM A STATE OF EMERGENCY** to exist in Glenn, Humboldt, Marin, Napa, Santa Clara, Solano, and Trinity Counties.

IT IS HEREBY ORDERED THAT:


1. All agencies of the state government shall utilize and employ state personnel, equipment, and facilities for the performance of any and all activities consistent with the direction of the Office of Emergency Services and the State Emergency Plan. Also, all individuals are to obey the direction of emergency officials with regard to this emergency in order to protect their safety.
2. The Office of Emergency Services shall provide assistance, if appropriate, under the authority of the California Disaster Assistance Act, Government Code section 8680 et seq., and California Code of Regulations, Title 19, section 2900 et seq.

3. The restrictions set forth in Penal Code section 396, which are automatically triggered upon proclamation of a state of emergency, are suspended, and no such restrictions are imposed, with respect to the February 2024 Storms in Glenn, Humboldt, Marin, Napa, Santa Clara, Solano, and Trinity Counties.
4. The California Department of Transportation shall formally request immediate assistance through the Federal Highway Administration's Emergency Relief Program, United States Code, Title 23, section 125, in order to obtain federal assistance for local road and highway repairs or reconstruction that are needed due to the February 2024 Storms.

I FURTHER DIRECT that as soon as hereafter possible, this Proclamation be filed in the Office of the Secretary of State and that widespread publicity and notice be given of this Proclamation.

This Proclamation is not intended to, and does not, create any rights or benefits, substantive or procedural, enforceable at law or in equity, against the State of California, its agencies, departments, entities, officers, employees, or any other person.
