- This form is used to request allocations for state projects with state and/or federal dollars.
- Pending on program and phase, the form will open-up certain sections. Not all options are included in this training, but an overall view and a general idea of what is involved in completing an allocation request is.

How Do I Fill Out Funding Program? (Continued)

Senate Bill 1 (Beall, 2017) also known as the "Road Repair and Accountability Act of 2017," increases transportation funding. SB1 stipulates a number measures intended to hold transportation agencies more accountable on the expenditure of SB1 funds, plus reform and streamline how a wide-range of transportation projects are delivered.
