# Underserved Community

COMBINATION OF BOTH STATE AND FEDERAL TOOLS/DEFINITIONS

## FEDERAL METRICS

*More than or equal to half of all census tracts must be defined by at least one of the following to be eligible;*

- By environmental justice disparity (Historically Disadvantaged Census Tracts/Justice40)
- By income disparity (Areas of Persistent Poverty)
- Many other federal metrics endorsed by the federal RCP

## STATE METRICS

*Not required to be eligible. Points assigned on sliding scale.*

- By income disparity (80% AMI or less)
- By health disparity (Healthy Places Index 3.0)
- By environmental justice disparity (CalEnviroScreen)
- Native American Tribal Lands

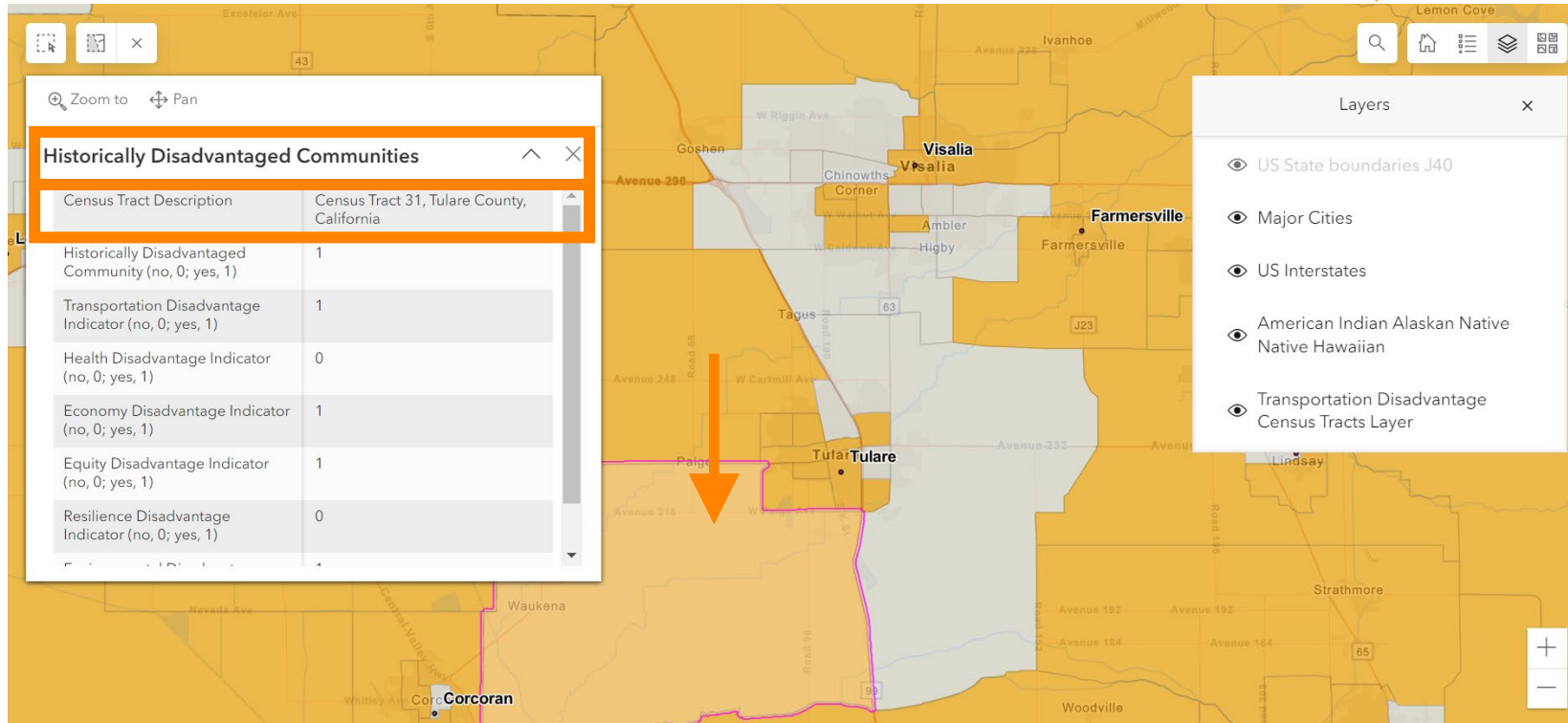

### Areas of Persistent Poverty Project (APP) and Historically Disadvantaged Community (HDC) List

Last Updated January 10, 2023

Use this tool to determine if your grant project is within an Area of Persistent Poverty or a Historically Disadvantaged Community.

**Area of Persistent Poverty Definition:** "Area of Persistent Poverty" is defined for the grant program as:

- 1) Any **County** that has consistently had greater than or equal to 20 percent of the population living in poverty during the last 30-year period, as measured by the 1990 and 2000 decennial census and the most recent (2021) annual Small Area Income and Poverty Estimates as estimated by the Bureau of the Census.
- 2) Any **Census Tract** with a poverty rate of at least 20 percent as measured by the 2014–2018 5-year data series available from the American Community Survey of the Bureau of the Census.
- 3) Any U.S. Territory.

- **Follow all the instructions** listed in the spreadsheet.
- Every census tract within the Proposed Improvement Area shall be listed in the first column of Attachment C.
- Add as many rows as needed to capture all census tracts but add them between the appropriate rows and **carry down the formula in Column (5)**.
- Ensure the grey formula cells are populating appropriately. If any discrepancies, **contact the RC:H2B email before the submission deadline** for troubleshooting. Late submittals will not be evaluated.
- **Attach your proof** to the PDF of the spreadsheet.

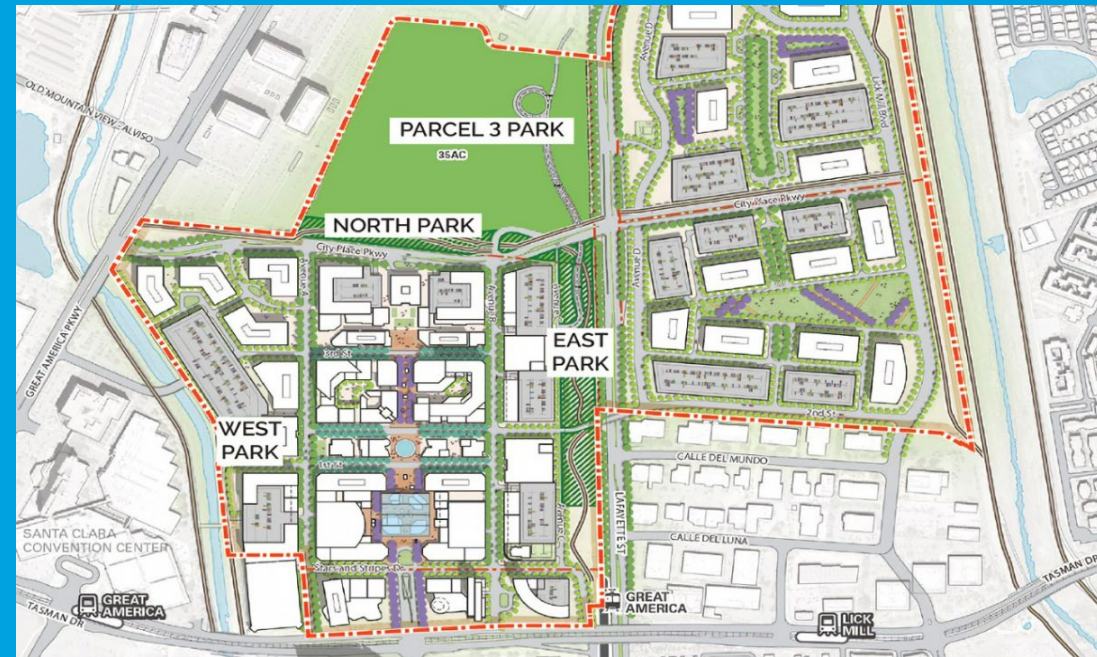
