 3. 5. SB-1 program manager is Jim Davis.

 3. 8. Highway Bridge Program (HBP)
 3. 8. 1. HBP Project Programming for the 2019 FTIP has been completed and are posted on the DLA HBP website and the respective lists have been sent to MPO's to program into their 2019 FTIP
 3. 8. 2. HBP Managers completed the one day HBP Training/workshop to all District and local agency staff around the state. 12 training classes were held, one in each of the Caltrans districts. A makeup training will be scheduled the first part of next year and will be recording the training and then post it on the DLA HBP website.
 3. 8. 3. Project delivery rules are being developed by the Local HBP Advisory Committee. The rules can be categorized under funds management and time management. Looking to finalize the rules in the December meeting. Once approved, they will be applied immediately to this

FFY's of programmed projects. Will have discussion on whether we need to send out an office bulletin now and then incorporate into next year's update.

3. 8. 4. Prop 1B Seismic Bridge Project delivery agreements have been completed and signed by the respective local agency and Ray Zhang, DLA Division Chief. The commitment includes milestone dates for the delivery of the project with the understanding that if milestones are missed, Prop 1B(local match) and HBP funds may be taken away from the project and federal funds that have been expended on the project will need to be paid back.
3. 9. HSIP
 3. 9. 1. For Cycle 9, received 351 HSIP applications requesting around \$418M of federal HSIP funds. HSIP managers have completed the process of reviewing the applications and are in the final stages of the constraining process to determine which projects to fund with the limited HSIP grant funds available.
 3. 9. 2. Looking to post the HSIP list sometime mid-November at the earliest to the end of November at the latest. Soon after, the list will sent to Programming and be sent out to the MPO's to add to their 2019 FTIP.
 3. 9. 3. Once Caltrans management reviews the list, we will post it on line and let the DLAEs in each district know that the list has been posted and to notify their respective agencies.

4. RTPA Update

4. 1. We will have a transportation workshop to kick off the new legislative session.
4. 2. Multi-modal corridor plan guidelines from CTC will be coming soon – The RTPA-s are working to keep the guidelines flexible on the subject of induced demand. We will be able to keep our documents consistent.
4. 3. SB-1: 1.3 billion has been programmed – Many baseline agreements have been queued up for adoption.
4. 4. CT has gone over 133 million in efficiencies savings- that waws above and beyond the SB-1 requireemnt of 100 million. – value analysis and CMGC included in this.

5. 1. We ha ve requests over 2 biullion which exceeds available funding. We will have staff recommendationzs by December 31 this year.
5. 2. We are working on scheduling for all the SB-1 programs draft expected by the end of this year.
5. 3. Other SB-1 program Baseline agreements – 64 SHOPP baseline agreements have been approved, provisionally approved 32 agreements for ATP/LPP/SCCP/TCEP. We are waiting for additional benefit data on these 32.

6. FHWA Update

6. 1. Funding is expected – we anticipate fully funding our program. FHWA is funded by the highway trust fund so we can still work with you even in a shut-down.
6. 2. FHWA has a new executive director – Tom Everett.

- 6. 3. LPA program manager position is still vacant. We expect to advertise within the next couple of months.
- 6. 4. We will be working on honing our oversight process with Caltrans.
- 6. 5. FHWA nationwide payment review, based on statistically valid random sampling, has revealed that there is a national picture that says there may be as much as \$997 million in improper payments (extrapolated). California has only one improper underpayment of \$0.03. (three cents.) Our allowance is only 100 million. There is concern in HQ over our review process, because of this. Caltrans updates its LAPM to ensure compliance and ensuring we don't have improper payments.
- 6. 6. National program – special experimental projects where more authority is delegated to states – We expect to hear from California on items they would like delegation for – things that will streamline the process.
- 6. 7. NEPA/CEQA reciprocity – two states have pilot efforts to demonstrate their laws and procedures are as rigorous as federal NEPA. In California the Governor can waive CEQA and that is a concern for the NEPA/CEQA reciprocity. California is waiting for the federal rule making.
- 6. 8. FHWA thanks all for their efforts in resolving inactive obligation issues.

7. Contractor Prequalification Process / De-Mobilization Bid Item

7. 1. Local agencies can adopt a prequalification process for their projects. They must get approval from FHWA division administrator prior to implementation.
7. 2. CT will put out enhanced guidance in Chapter 15 of the LAPM. You cannot unfairly restrict competition – things like local preference, etc. City of Bakersfield uses a prequalification process. Their process is very rigorous.
7. 3. Contact Mike Giuliano for details on the Bakersfield process. (mike.giuliano@dot.ca.gov)
7. 4. Demobilization bid item: In Caltrans standard specs, local agencies can retain \$10,000 to guarantee compliance with final project documentation requirements. Local agencies can modify this if they want. Caltrans would like to keep this from being a competitive bid item, as opposed to a standardized item.

9. Added Agenda item: Risk-based approach to Local Assistance Environmental assessments (Pilot) This was discussed between items 7 and 8.

9. 1. What is a Risk-Based Approach?
 - Caltrans decides on the NEPA Class of Action based on information provided at PES form stage.
 - Consultation document length/detail led by Project Sponsor (Local Agency) with Caltrans offering principles of 'non-duplication', 'inclusion by reference' and clear differentiation between Local Agency and Caltrans led-text.
 - If following consultation, it is concluded there are no significant effects then the FONSI & Final Environmental Assessment is signed. If not, move to an Environmental Impact Statement
9. 2. Principles of a Local Assistance EA Outline
 - Clarity on the relationship between the Local Agency and Caltrans
 - Builds directly from PES form
 - Leaves CEQA format/content to Local Agency
 - Extremely concise, avoiding duplication, reliant on technical studies included by reference
 - Consistent with NEPA Assignment
 - Alignment with federal (NEPA) objectives
 - - CE Q question 36, implementation of procedural provisions of NEPA
 - - TA 6640.8A (FHWA), eNEPA (FHWA)

 - Less developed than existing annotated outlines

10. A & I – Hiring Caltrans for ICAP for small agencies

10. 1. Smaller agencies cannot easily get together and find a linking benefit for hiring Caltrans for ICAP. We would like to be able to have this available in smaller agencies.
10. 2. Can A&I set up something which would be funded by local agencies, where they can do ICAP for smaller agencies? Training will not suffice as a solution.
10. 3. Caltrans A&I currently sees a conflict in that they cannot do the ICAP and then audit their own work. This would be counter to generally accepted management practices / accounting principles.
10. 4. Can A&I ask the SCO if they would be able and willing to do the ICAP for small agencies? We would like to find out if this is an option.
10. 5. Outcome: A&I will work with Local Assistance to see if there is anything that can be done under the existing contracts local agencies have with the SCO.
