- 4. Asphalt Subtask Group Work Products
 - A. Use RAP up to 40% in HMA
 - a. We're moving forward with pilot projects. There are 4 projects planned to be awarded in Spring/Summer 2022. District outreach has occurred.
 - B. RAS up to 3%
 - a. 1 project was piloted (El Dorado 49) and UCPRC is evaluating. More projects are being sought.
 - C. Post Plant Gradation
 - a. 5 projects are in construction and 11 are being planned.
 - D. 10% RAP in RHMA-G
 - a. The impasse was resolved at the ATG level. Recommendations were made. 4 pilot projects will be awarded in Spring.
 - b. The impasse resolution resulted in consensus has been reached to modify as stipulated below:
 - Both 3% & 4% will be accepted with the following changes to criteria:
 - Keep acceptance on 4% as ±1.5%
 - \circ Change acceptance on 3% from $\pm 1.5\%$ to -1.0% + 1.5%
 - Contractor can decide at the mix design stage
 - STG needs to determine pilot project sizes and perform data collection/evaluation prior to standard specification submittal.
 - d. ATG would like to limit the size of the pilot projects to smaller sizes.
 - e. ATG would like to ensure adequate testing (a specific number) is performed during the pilot stage.
- 5. Pavement Preservation Subtask Group Work Products

- A. Section 37 Update
 - a. The final report will be sent out for signature tomorrow. I apologize for the delay.
- 6. In-Place Recycling Subtask Group Work Products
 - A. Write nSSPs and Pilot CCPR on Caltrans Projects
 - a. The nSSPs, test method, and MPQP are being reviewed by OCCS and minor comments are expected. Outreach for awareness is also occurring.
 - B. CCPR Pilot Projects
 - a. A decision document may be considered to get the pilot projects underway and create a group later to evaluate the data.
- 7. EC Updates for ATG
 - a. A final report signature page needs to be added. It will need to be approved by ATG and EC. A presentation may be required.
 - b. Scoping documents may not be approved. The mission, vision, and goals need to be clearly stated. It's encouraged that the short scoping documents also explain the mission, vision, and goals. Be direct in the scoping documents.

 - b. Kelly Tim Greutert is acting in construction for Ray Hopkins. Jeremy Peterson-Self is acting for Tim Greutert until 03/11/22.
 - c. Sarah The scoping document hold should be lifted early April. We are hoping we will have the personnel to accommodate. Jacquelyn Wong will be returning late April, but will be attending ATG meetings at the beginning of April to catch up.
 - d. Joseph There is no update needed for the Section 37 Update to the Construction Manual.
 - e. Chu Paul Schneider at FHWA will be retiring mid-March. I will be at a balance mix design peer exchange with California, Florida, and Texas when it is scheduled. I would like to know when the Pave Scan demonstration would occur at UCPRC.
 - UCPRC is scheduling a demonstration and will record. Brandon will send it to the group.
