1. Introductions
 2. Bin Lists
 - a. Due to changes in management, scoping documents need to be clearer on the goals that will be accomplished.
 3. Pavement Bin List
 - a. The bin list needs to be updated with the new issues. Industry would like to prioritize as well.
 4. Industry Priorities Poll
 - a. CRCP – There are issues with concrete pavement design and concrete paving construction knowledge. The PMPC will try to work on this, but the members are willing to work together to develop training to assist for CRCP. A short scoping document will be developed to try again.
 - b. Skid Testing – Industry does not approve the decision to check the worst spot. Caltrans will not change the test method, but the spec is being worked on at the moment. A decision document may be considered as long as consensus remains. The item “Texture specification conflicts with friction requirements” should be handled by this as well.
 - c. Add Performance specifications with pay factors to the bin list for scoping document development.
 - d. “Requirement to cut dowel basket support wires” can be developed into a decision document.
