1. R-Value Test Preparation for Lime Stabilization
 - a. The final scoping document was approved, but the EC had questions. A follow-up meeting occurred. One of the questions was if IA had a chance to review.
 - i. If there are any test method changes, the scoping document should include IA review.
 - ii. Action item that occurred from the meeting was obtaining IA feedback on the scoping document
 2. Performance-Based Specifications Workshop Feedback
 - a. The workshop/kickoff meeting occurred last Wednesday.
 - b. We need to determine timelines; especially where things will move quicker or slower.
 - i. EPDs and LCAs may be difficult to determine what all needs to be done.
 - ii. A separate EPD & LCA meeting may occur, including ATG, Dominika Ercolini, and John Harvey to discuss options.
 - iii. We may end up (dis)incentivizing EPDs for pilot projects. NRMCA has EPD related research online.
 - b. A follow up meeting will occur after the development of a more comprehensive plan is created.
 - c. The spec needs to be cleaned up (aka clean up items that are prescriptive). It may be beneficial to create an optional sustainability spec.
 - d. The meeting could have been streamlined and participants reduced, but it was a good idea to keep the group large to create understanding.
