 - a. Committee Member Updates:

- 4. ATG Updates
 - a. RAP up to 40%
 - i. Tony Limas is working with Kee and Saeed on adding a Data Collection and Data Evaluation to the scoping document.
 - ii. There are two pilot projects that were awarded this spring in D-10 and D-8. The D-8 project has started production and paving. The D-10 project has not started production.
 - b. RAS up to 3%
 - i. CT chair and Industry lead working on adding a Data Collection and Data Evaluation to the scoping document.
 - ii. (Cathrina) UCPRC Report has been routed for review
 - 1. Charley EC shouldn't have to comment on technical reports; Maybe having a briefing/presentation on this report from the work group would be a better approach
 - a. Tom agrees that the EC should not be reviewing reports like on the RAS, does recall that the report was asked for, by the EC, a few months ago.
 - b. Note: there is no change to the SOP to have the EC review reports for anything other than information sharing.

 - i. WPG is working on Implementation Plan and Milestone Extension.
 - ii. 16 pilot projects data collection has started: 2 from industry and 2 from Caltrans
 - d. 10% RAP in RHMA
 - i. Two pilot projects in D4 had their preconstruction meeting and will start paving this month. Continue to monitor pilot projects.
 - ii. METs will get more involved with the data collection
 - 1. There are 4 projects awarded.
