INTRODUCTION

California Public Road Data 2019

This publication, the “California Public Road Data 2019”, contains statistical information derived from the Highway Performance Monitoring System (HPMS). HPMS is a national highway information system that includes data on the extent, condition, performance, use, and operating characteristics of the Nation's highways. While every effort has been made to ensure accuracy and completeness of the data, users should carefully evaluate its accuracy, currency, completeness, and relevance for their purposes.

In 2014, a Linear Referencing System (LRS), which links the HPMS attributes to geospatial data for all public roads, was created to meet the Federal Highway Administration (FHWA)'s All Road Network of Linear Referenced Data (ARNOLD) requirement. The reported mileage in this report is based on this LRS network. During the process of crosschecking the LRS route ownership and mileage against data from local agencies, it was found that the LRS tallied substantially more mileage. It means that there are possible differences in terms of ownership (public/private roads), designation (roads/bike paths/trails) and geospatial attributes (begin/endpoint, length). Caltrans has been continuously improving the quality of the LRS network. As a result, the maintained mileage reported in past years has been fluctuating as follows:

Year 2014	174,855 miles
Year 2015	195,834 miles
Year 2016	180,800 miles
Year 2017	176,214 miles
Year 2018	175,589 miles
Year 2019	175,561 miles

Caltrans will continue to partner with local, federal, and other state agencies to verify the private/public ownership of roadway segments and to improve the quality of the LRS network and transportation data.

The 2019 statewide estimated Vehicles Miles Traveled (VMT) has shown a slight decline partly because of adjustments we made to the growth factors on local roads. These adjustments are based on our larger traffic count data sample size to improve the VMT estimates and projections. Further adjustments may be expected based on future traffic count data collection and reflection of travel pattern changes under the COVID-19 environment.

HPMS Background

HPMS was originally developed in 1978 as a perpetual database to replace special biennial condition studies that had been conducted by the States since 1965. The HPMS has been modified several times since inception, most recently in 2010; changes in coverage and detail have been made since 1978 to reflect changes in highway systems, legislation, and national priorities, to reflect new technology, and to consolidate or streamline reporting requirements.

The major purpose of the HPMS is to support a data driven decision process within FHWA, State Transportation Departments, and Congress. The HPMS data is used extensively in the analysis of highway system condition, performance, and investment needs that make up the biennial Condition and Performance Reports to Congress. These reports are used by the Congress in establishing both authorization and appropriation legislation, activities that ultimately determine the scope and size of the Federal-aid Highway Program, and determine the level of federal highway taxation. This data is also used for assessing changes in highway system performance brought about by implementing funded highway system improvement programs under the Government Performance and Results Act, and for apportioning Federal-aid Highway Funds to individual States under Fixing America's Surface Transportation (FAST) Act. HPMS is a nationally unique source of highway system information that is made available to those in the transportation community for highway and transportation planning and other purposes through the annual Highway Statistics and other data dissemination media.

Description of Data Tables

Table 1 2019 Maintained Miles, Lane Miles and Annual Vehicle Miles of Travel by Type of Jurisdiction

This is an overview of the public road mileage, lane miles, and annual vehicle miles in California and the agencies that maintain and have jurisdiction over them. This includes roads in the 482 incorporated cities and the unincorporated parts of the counties in California. San Francisco, being a city and a county, is included in the cities since there is no unincorporated part of that county/city. State and federal agencies maintain most of the rest of the mileage. There is a small amount of public road mileage maintained by private and other entities.

Table 2 2019 Maintained Miles, Lane Miles and Annual Vehicle Miles of Travel by Functional Classification

A statewide summary of the miles, lane miles and annual vehicle miles traveled (AVMT) for each of the roadway functional classifications. There are now seven Functional Classifications: Interstate, Other Freeways & Expressways, other Principal Arterials, Minor Arterials, Major Collectors, Minor Collectors, and Locals. The Major Collectors in rural and Collectors in urban have been combined under one code. Any public roads not classified as Arterials or Collectors have been classified as Local.

Table 3 2019 HPMS Mileage Summary by Functional Classification, Population and Net Land Area

Urbanized areas are delineated by the urban boundaries set by the United States Census Bureau. Rural areas contain population centers that have less than 5,000 people in population, or areas below a population density of 1,000 persons per square mile. Small urban areas are population centers with more than 5,000 but less than 50,000 people. Urban areas have over 50,000 people. An urbanized or rural area may or may not contain an incorporated city and the urban boundary does not necessarily follow city corporation lines. The population of each urbanized area is derived from the population data of each city and county as published by the State Department of Finance. The net land area excludes the large bodies of water (7,200 feet in least direction).

Table 4 2019 HPMS Estimated Daily Vehicle Miles of Travel by Urban Area and Functional Classification

This table is organized similarly to Table 3. This gives the Daily Vehicle Miles of Travel (DVMT).

Table 5 2019 Mileage of Maintained Public Roads in Each County by Type of Jurisdiction

Jurisdictions within each county, incorporated and unincorporated, which have reported public road mileage.

Table 6 2019 Maintained Miles & Daily Vehicle Miles by Travel Estimates by Jurisdiction

The mileage figures originate from the annual maintained mileage reports submitted by the agencies.

Table 7 2019 Road Miles by Functional Classification by County

These figures include all public road mileage from all jurisdictions within each county.

Table 8 2019 Miles, Lane Miles and Daily Vehicle Miles of Travel by Urbanized Area

Similar to Tables 3 and 4, this also gives the lane miles.

Table 9 2019 Miles, Lane Miles and Daily Vehicle Miles of Travel by Metropolitan Planning Organizations

This provides the 18 Metropolitan Planning Organizations (MPOs) officially recognized in California as of 2014 with data for their regions. Note that all but two of these MPOs have their boundaries exclusively along county lines. The miles, lane miles, and DVMT shown for the Tahoe Regional Planning Agency include only the portions in California and not Nevada.
