Comments:

- Mr. Kong - Caltrans received the letter from FHWA on 1/13/2026 confirming substantial conformance of the CA MUTCD 2026 edition with

the 2023 Edition of the National Manual on Uniform Traffic Control Devices (NMUTCD). Caltrans will be sending letters issuing the manual, effective January 18, 2026, within the 2 years of effective date of the final rule adopting the National MUTCD 2023. There is an attachment with a list of changes to the CA MUTCD 2026 after the CTCDC motion/recommendation. Most of the changes are when we did the initial substantial conformance check with FHWA California division. After the documents passed through CTCDC we sent documents to Steve (FHWA) and he had some comments and worked through them to come up with the final draft and we had different checks such as the signs group check the figures and not only in part 2 but in the other parts of the manual to make sure there was consistency.
