# INTRODUCTION

## WORKING TOGETHER TO MAKE CALIFORNIA ROADS SAFE

An introduction from the 2020–2024 SHSP Steering Committee

Everyone in California should be able to travel across the state and arrive safely at their destination. California's 2015-2019 SHSP reported a 30% reduction in fatalities from 2005 to 2012. The current traffic safety picture is not as positive. In 2017, more than 3,600 people lost their lives in traffic collisions and more than 14,000 people were seriously injured. Not only is this a tragedy, there is also an economic cost. According to the National Highway Traffic Safety Administration (NHTSA), traffic collisions cost California approximately \$20 billion per year<sup>1</sup>. Unfortunately, California is not alone, and traffic fatalities are on the rise across the nation.



In Spring 2019, we held forums to gain feedback for developing the 2020–2024 SHSP. The feedback guided our efforts in establishing the 16 challenge areas that will develop specific, measurable, achievable, relevant, and time constrained (SMART) action items to reach the goal: Towards Zero Fatalities and Serious Injuries.

## WHAT IS THE SHSP?

The California Strategic Highway Safety Plan (SHSP) is a comprehensive, statewide transportation safety plan which provides a framework for reducing fatalities and serious injuries across all modes of travel and on all public roads. Started in 2005, the SHSP is updated regularly to ensure continued progress and to meet changing safety needs. Currently, over 580 safety stakeholders from over 230 public and private agencies and organizations work together on this effort under the guidance of the SHSP Executive Leadership and SHSP Steering Committee. The SHSP addresses the "5 Es" of traffic safety: Engineering, Enforcement, Education, Emergency Response, and Emerging Technologies.
