Construction is behind schedule due to severe weather, unforeseen underground conflicts, and supply chain delays for certain materials needed for the project. Most notably, there was a significant delay in obtaining final approval from the Department of Water Resources to begin demolition of the existing bridge and construction of the new bridge over the California Aqueduct.
