- 1) Are there any alternatives to the replacing California 6C Electronic Toll Collection Standard with the 6C Coalition AVI Standard?
  - Replacing to the 6C Coalition AVI standard would provide minimal impacts to current toll operations. Changes to other alternatives such as other AVI protocols/standards, or Road Use Charging model would require technology and policy changes for the Agencies.
- 2) What are the benefits of the replacing California 6C Electronic Toll Collection Standard with the 6C Coalition AVI Standard? What are the drawbacks?
  - Benefits:
    - Consistent standards with current and/or future 6C Agency users.
    - Possible easier interoperability integrations (hub to hub, national interoperability).
    - Future expansion of 6C use by other agencies will be consistent and create easier adoption/integration with them.
    - New 6C standard AVI standards help all Agencies remain up to date with addressing identified issues or modifications (such as 'Bit-Flip', new bit allocations) with transponders.
  - Drawbacks:
    - Changes/additions to the 6C Coalition standards may impact California Agencies current operations/policies.
    - Changes or updates to standards must be agreed upon by a larger group rather than a smaller group within California.
- 3) Please discuss any effects, including projected timetables, from replacing California 6C Electronic Toll Collection Standard with the 6C Coalition AVI Standard.
  - Toll system software and hardware updates may be required by Toll System Integrators to have current operations to comply with 6C Coalition Standards.
  - Additional testing/verification will be needed once updates are deployed.

- Timing impacts for any required updates, to long range plans, or procurement cycles.
- 4) Please describe any impacts replacing California 6C Electronic Toll Collection Standard with the 6C Coalition AVI Standard.
  - Cost impacts with updating software/hardware to accept new 6C Standards
  - Changes to system may not align with Agency timelines with upgrading tolling systems (may need to occur costs to upgrade system for a short period of time before transition to a new Toll system)
  - Timeline to get any changes in place and coordinating with planned major toll system upgrades/replacement.
  - Coordination/planning for changes and updates needed between agency roadside systems and regional back office system(s)
- 5) Would you support Caltrans also adopting the latest versions of the International Organization of Standardization (ISO) standard for radio frequency identification devices as part of this rulemaking?
  - From a roadside toll operations perspective, adopting the latest version of the ISO standard would be supported by GGB.
- 6) Will the regulation affect the ability of California businesses to compete with other states by making it more costly to produce goods or services here?
  - From a roadside operations perspective, the regulation changes should not affect the ability for California businesses to compete with other states.
- 7) What are the fiscal impacts on state and local government?
  - From a roadside operations perspective, we anticipate minor fiscal impacts from any toll system upgrades (hardware/software) required to transition operations to the new standards.
- 8) Are there any issues regarding fairness of competition?
  - Don't believe there will be issues in fairness of competition with adopting current standards as this can help provide a 'level playing field' among vendors providing solutions to the same standards.
- 9) Are there any issues regarding individual privacy?
  - From a roadside operations perspective, there should not be any issues on individual privacy with ISO standards to be adopted. We would need to
