## California Transportation Permits Advisory Council (CTPAC) Steering Committee Meeting

### Thursday, August 3<sup>rd</sup>, 2023 11:00 AM to 1:00 PM

## Location: Port of Long Beach Maintenance Facility 725 Harbor Plaza, Long Beach, CA 90802

## Meeting Summary

## Item #1 – Welcome, Agenda and Purpose of Meeting.

CTPAC chairperson Eric Sauer, Chief Executive Officer of the California Trucking Association (CTA), welcomed attendees. Eric appreciated everyone for participating in the meeting, including the trucking industry, the California Department of Transportation (Caltrans) and the California Highway Patrol (CHP) representatives.

## <u>ltem #2 – Caltrans Updates</u>

Thomas Schriber, Chief of Caltrans' Office of Commercial Vehicle Operations (CVO), thanked everyone for attending the meeting. Thomas introduced Devinder Sandhu, the lead for single trip and variance permits, Xinyue Yang, the Permit Policy Engineer, Michael Lee, the leading bridge design engineer in Structure Maintenance & Investigations (SM&I), and Raha Hezar, the senior bridge engineer in SM&I in the meeting.

The Transportation Permits Office has been moved to the N Street building since last October and most boxes have been unpacked. Since most employees are teleworking most days, there are only 14 cubicles with a few hoteling cubicles for those employees who come to the office one or two days per week.

Caltrans Information Technology (IT) staff are still working on implementing the electronic interface for annual and repetitive permits, similar to STARS2, and creating a searchable repository of inspection reports.

A customer service survey was shared with the members in the last CTPAC meeting and Thomas thanked everyone for providing feedback. In response to the feedback, a new virtual call center is being developed to better assist the need of the customers.

Thomas also pointed out that there are multiple vacancies in the Permits Office and the Office is struggling with permit turnaround times. Thomas asked for members' patience and understanding while backfilling the vacancies. CA Truck Networks and Truck Weigh Stations have been added to QuickMap. Thomas thanked everyone's assistance for testing the application.

Transportation Permits Manual (TPM) Chapter 1 indicates that STAA vehicles will not be considered for an exception to use California Legal routes unless the load they will carry cannot be hauled on a California legal vehicle, which is consistent with approved TPPM 2002-03.

However, the practice has been to issue permits based on exceptions to STAA on CA Legal routes (including restrictions) on a case-by-case basis, depending on whether load and combination could fit. Per TPPM 2002-03 and updated TPM Chapter 1, the only exceptions should be when the load cannot be hauled on CA Legal vehicle. Thomas asked members what impact there will be if policy and practice are applied consistently.

A few members responded there is no need to revise the policy but provide constant and additional training to permit writers to enforce the policy. Sometimes denials are given even when the load cannot be carried on a California legal vehicle. It was suggested to add a note on the permit application explaining that load cannot be hauled by a California legal vehicle.

Michael J Lee, the Office Chief and leading bridge design engineer in Structure Maintenance & Investigations (SM&I), shared some information regarding bridge goods movement rating, the funding source for bridge goods movement and the prioritization of bridge goods movement projects.

## <u>ltem #3 – CHP Updates</u>

Captain Nick Doko shared that CHP has maintained a great working relationship with the industry, Caltrans, local agencies, etc. and please feel free to reach out to CHP if there is any concern.

Sergeant David Kelly said CHP is committed to uniform enforcement. If there is an issue, try to resolve the issue on the local level first. If the issue still exists, then bring the issue to headquarters' attention. Sergeant David Kelly also shared that the 2023 Commercial Vehicle Safety Summit (CVSS) will be held on October 4, 2023, in Garden Grove, California. # <u> Item #4 – POLB Heavy Haul Route Update</u>

Matthew Lyman, Intermodal Operations Coordinator from Port of Long Beach (POLB), shared some latest updates regarding the 9th Street closure and the heavy haul route improvement project.

The 9th Street railroad crossing was closed on March 9, 2019, in a move that will improve rail operations and promote the speed of moving goods through the Port. During the time of closure, oversize trucks and cargos utilize alternative routes to transport goods. For certain oversize trucks that are unable to utilize the alternative routes, the Port offered special permits to traverse the crossing with approval from the City of Los Angeles (LA), the County of LA, and Caltrans.

The Heavy Haul Route Improvement Project will allow 300' long, 20' wide oversize loads to transit the 9th Street at-grade crossing. The Project is essential to provide transport options for Oversize/Overweight (OS/OW) loads.

POLB urged members to provide support letters regarding the expansion project on Anaheim Way and Farragut Avenue in the last CTPAC meeting. Los Angeles Planning Commission approved the expansion project in June 2023 and POLB thanked members for continued support.


POLB shared that the first phase of the Long Beach Pier B rail facility project is 50% done with the design phase and is expected to be completed in 2025. The second phase of Long Beach Pier B's early rail west expansion project that adds additional tracks inside the existing Pier B yard is expected to be completed in 2027.

### Item #5 – Roundabouts on State Highway System (SHS)

Caltrans staff from the Division of Design were unable to attend the meeting. Thomas Schriber shared that a new oversize-overweight (OS/OW) Design Vehicle Template has been added in Caltrans Highway Design Manual (HDM)Section 405.10 and Figure 405.10B(see below). After that, designers have been using it statewide when they are designing a roundabout, modeling truck movements and making adjustments (for example: adding truck blisters on entries and exits or modifying the truck apron around the central island, etc.) for accommodations. Caltrans Design encouraged the use of the steerable trailer when the OS/OW vehicle is modeled.

# d) <u>Variance</u>

Several topics were discussed during the workgroup meetings.

- 1. Variance transportation permits turnaround time (one variance permit writer out long term, new one in training).
- 2. TPPM proposal to eliminate inspection reports, "All previous verbal agreements have not been honored, so written policy is necessary, and industry proposes elimination of inspection reports all together". IR's benefit permit writers.
- 3. Incorrectly denied permits (STARS) vs. correctly denied permits.
- 4. Customers submit Variance permit applications for pre-approval but permit never gets issued. Caltrans cannot capture the cost and the resources could have been spent on pending permits needing issuance.
- 5. Coordinate with construction on temporary restrictions and detours.
- 6. No coordination between Caltrans and local jurisdictions to mitigate these mainline closures and restrictions, CVC Caltrans and Local Cities and Counties jurisdiction.
- 7. Caltrans districts not updating construction restrictions that are no longer in effect.
- 8. Construction projects causing "pinch points" for industry (I-5 (Waldon OC) and I-15 (City of Hesperia).
- 9. Upgrade structures for transportation permits.
- 10. Heavier weights due to batteries for electric trucks.
- 11. Variance permits could be broken down into a combination of STARS and Variance Permit, i.e., one bridge weight violation on entire route.
- 12. CVO: IT proposal to automate structures review routing and bridge list.

Lorin Sabin said that the permit turnaround time is the top priority, and the variance workgroup will continue to work with Caltrans to address the issue.

## Item #7 – Caltrans Action Items Updates

Xinyue Yang, Permit Policy Engineer, shared some updates.

Caltrans shared the draft revision of the Transportation Permits Manual (TPM) Chapter 1 in the last CTPAC meeting and received comments from CHP and CTPAC members. Caltrans incorporated the comments and sent the revised draft to CHP and CTPAC members for concurrence. TPM Chapter 1 is now published on the Caltrans website for public use.

In addition to TPM Chapter 1, two new Transportation Permits Policy Memorandums (TPPMs) were shared with the group in the last meeting as well. TPPM 2023-01 Concrete Panels and TPPM 2023-02 Legal Size Vehicle with Telemetry Data Gathering Systems are also published on the Caltrans website.

Xinyue provided an update on the route classification request of Route 70 in Plumas County from Chandler Road West to Greenville Wye. The request was to change the current brown classification to red requiring CHP escorts for safety reasons. The office of CVO continued to work with District 2 for route reclassification and red route summary modification.

Regarding CTPAC Work Group's Proposal of Inspection Report, Caltrans agreed to create a searchable database for inspection reports with the approval from the management team. An IT project has been created and is in the queue. The project will be worked on in the order received.

CA Truck Networks and Truck Weigh Stations have been added to QuickMap and both web version and mobile (iOS and Android) versions are available to the public as well. Free feel to explore and utilize QuickMap.
