Transportation Permits Policy Memorandum

Subject:LEGAL SIZE VEHICLE WITH TELEMETRY DATA GATHERING SYSTEMSDate:May 18, 2023Policy:TPPM 2023-02Reference:CTPAC WG12-041723-002

Objective

This policy will:

- Temporarily define telemetry data gathering systems to include camera monitoring systems (CMS), LIDAR, RADAR and accessories (e.g., sensor racks, transducers etc.).
- Administer permit issuance to these extralegal width trucks until telemetry data gathering systems are defined in the California Vehicle Code (CVC).
- Add Section 202.13 (a) of the Transportation Permits Manual.

Background

Telemetry data gathering sensors represent a new technology which provides telemetry data essential to the safe navigation of autonomous vehicles. When mounted as a load on an auxiliary rack, the nature of the sensor rack's mounting is such that it cannot be easily removed from the vehicle, even when the sensors are not in use. When a sensor rack is attached to an otherwise legal size and legal weight truck, the truck may exceed the legal width. Telemetry data sensors are a new technology and have not been defined in the CVC. Until this technology is defined in the CVC, these extralegal width vehicles must obtain a permit for travel on the California State Highway System.

Existing Documentation

California Vehicle Code

Section 35100. (a) The total outside width of any vehicle or its load shall not exceed 102 inches, except as otherwise provided in this chapter.

Section 35780. (a) The Department of Transportation or local authorities, with respect to highways under their respective jurisdictions, may, at their discretion

upon application and if good cause appears, issue a special permit authorizing the applicant:

(1) To operate or move a vehicle or combination of vehicles or special mobile equipment of a size or weight of vehicle or load exceeding the maximum specified in this code.
